Key Definitions

Data Subject: If you are completing this form and requesting your own personal data then you will be the data subject for the purpose of your request. However, if you are completing this form on behalf of someone you are representing, then the data subject will be the person that the information requested is about.

Which sections should I complete?

Sections 1, 2, and 5 should be completed for all applications.

Sections 3 and 4 (Representative Details and Authority to Release Information to a Representative) should only be completed if the application is being made by a representative (i.e. someone other than the person the data being requested is about).

General Notes

- The Parole Board will not release information without proper authority, and reserves the right to request further proof of authority or identity if necessary.
- We will acknowledge your request in writing.

How long will it take to get my data?

Once we are satisfied that you meet the criteria for disclosure of data under data protection law, and you have provided sufficient information, you should receive a response within 1 calendar month from the date that we accept your application for processing.
